

## The distribution of continuous time rank processes

**Abstract**. In this paper, we will give exact calculations of probability disrtributions of continuous rank processes in Brownian case, Brownian motion with drift case, Pinned Brownian motion case. These calculations are based on the results of the joint distributions of Brownian motion and its soujourn time. Also we give new exotic options using rank statistics and calculate the price of rank options.
